Living Declaration’s Preamble...

Whereas and in recognition of all the inherent dignity, sanctity, and pursuit of prosperity, health, and of the ethical, equal, and equitable inalienable Rights of all members of the Human Race are the Foundation of Freedom, Justice, Balance, Harmony, and Peace in the World, and...

Whereas any disregard and/or contempt for a human’s life or rights have resulted in barbarous acts, which have outraged the conscience of the larger group (Mankind), of any section, percentage, culture, ethnicity, gender, or skin hue that is collectively Mankind, and in the advent of a world in which human beings shall enjoy the freedom to Speak, freedom of Speech - being Truth (neither lies, nor hate) and in accurate report and accountable belief (not misinformation), and to enjoy the freedom from Slavery, Indentured Servitude, Oppression, Tyranny, Fear or Want has been proclaimed as the highest aspiration for all human-kind, and...

Whereas it is mandated, should any percentage of a culture, ethnicity, gender or identifiable group that is in part or partial; collectively mankind cannot be compelled without recourse, or to have recourse without reason; where in last resort, seek rebellion against Tyranny, Injustice, Inequity, Bigotry, Repression and/or Oppression of their Human Rights and shall be, must be, and should be protected by a Just and Equitably applied Rule of Law, and...

Whereas it is essential to educate and promote the development of friendly and equitable relations between nations, states, provinces, communities, groups, tribes, and/or percentage, culture or ethnicity, gender, or identifiable group that is collectively mankind, and...

Whereas the *United Peoples of the Earth* have in this Living Declaration reaffirmed their faith in the fundamental and equitable nature of Human Rights; in the dignity, sanctity, prosperity, and worth of the human person and in the equal rights of

men, women, disabled, gender (identified) and/or identifiable group and have determined to promote equal and ethical social progress, development and better standards of life for all its members in larger Peace and Freedom, and...

Whereas member Countries, States, Nation and/or Republic; Groups, Sections, Culture, Ethnicity, and/or Identifiable Group have pledged themselves to achieve, in equitable co-operation with the ideals of *W.E.C.A.N.* (World Ethical Congress of Allied Nations), and the promotion of ethical, universal and equitable respect for and the observance of Human Rights and all its fundamental Freedoms, natural to the collective body known as Mankind, and...

Whereas an ethical and common understanding of these Human Rights, its sanctity and freedoms are of the greatest importance for the full realization of this pledge, and...

Now, therefore a ***WORLD ETHICAL CONGRESS of ALLIED NATIONS*** proclaims ***THIS DECLARATION: THE UNIVERSAL DECLARATION OF ETHICAL HUMAN RIGHTS*** - a *Living Document*; as the common, equal and ethical standard of achievement for all the Peoples of Earth and all Countries, Nations, States and Republics of Earth, and to that end - every individual Human Being and every organ of any aspect of society, keeping this Living Declaration constantly in mind, shall strive by teaching and through education, promote the sanctity and respect for human life, human rights and freedoms and by progressive measures between, groups, sections, percentage, cultural, ethnic and identifiable groups, national and/or international, to secure the universal and effective recognition and mandated observance, both among all the nation/country members of any ***Congress of Allied Nations***, themselves and among all the indigenous peoples (born on Earth), its Territories, Regions, Provinces, Republics and Nation states - all under one jurisdiction.
